

Box and whisker plot

THE BOX AND WHISKER PLOT

The figure below outlines a skeleton of a box and whisker plot (also called the box plot). The box comprises of the middle 50% of observations. Thus, the lower end of the box, in terms of the measure to which it refers, is the first quartile and the upper end is the third quartile. The line in the box is the median. The broken lines extend downwards to the lowest value in the distribution and upwards to the largest value excluding outliers, i.e. extreme values, which are separately indicated and labeled.

The box and whisker plot provides information about the shape of the distribution, since it raises the question of whether the median is closer to the one end of the box.

Should the age for teenage pregnancy be set at seventeen years or younger, it seems that in beneficiary households (Table A above):

• 19% of women 18 to 22 years had a pregnancy while they were teenagers compared to 14% of those 23 to 30 years, 17% of those 31 to 40 years and 15% of those 41 years or older (no statistical significant relationship between age and teenage pregnancy).
